## Grossmann Uhren GmbH – Terms and Conditions of Press Kit Use by Journalists

The enclosed Press Kit (hereinafter: "Press Kit") is made available to authorised journalists by Grossmann Uhren GmbH (hereinafter: "Grossmann"). Current information technology developments, especially the use of the Internet as a communication tool, have increased the need for us to protect our intangible assets (brands, designs, patents, etc.) to prevent the misuse and manipulation of our images, logos, and other documents. For this reason, the use of this Press Kit and access to its content is restricted exclusively to professional journalists who have been authorised by Grossmann (hereinafter: "Journalists"). Furthermore, all future Press Kits are subject to the following Terms and Conditions of Use as well. Grossmann may unilaterally amend or revise these Terms and Conditions of Use from time to time. The amended or revised Terms and Conditions of Use shall take effect for all Journalists as of the date of receipt.

## Use of materials in the Press Kit

Grossmann maintains the Press Kit as a working tool for the exchange of press information and images, in particular, for the exchange and provision of current information about Grossmann (background information) as well as generally for its latest product press releases and brand/product logos, and for the communication of other privileged company information. The materials handed out with the Press Kits may be used exclusively for press activities (copied, reproduced, etc.) approved in advance by Grossmann, i. e. for the preparation of reports, articles, new items and press reviews through any media. Occasionally, Journalists will have access, prior to any public disclosure by Grossmann, to new press and product releases that may not be used, reproduced, copied or released before the fixed embargo date indicated in the release. By taking possession of the Press Kit and gaining access to further releases and content, etc., the recipient Journalists expressly agree to be bound by such embargo date. Any copying, reproduction, circulation or distribution of any material contained in the Press Kit to unauthorised third parties is expressly prohibited. Unless otherwise noted, Journalists must assume that all information and documents contained in the Press Kit are proprietary information and, as such, are protected under national intellectual property laws world-wide and international treaty provisions. Authorised Journalists may neither offer for sale, sell, auction, reproduce, nor share nor disclose to any third party, nor modify, display, report or otherwise use the Press Kit or any of the content in any way whatsoever except for the prescribed purposes as set out above. In particular, information and content made available with the Press Kit may not be used or displayed in any electronic medium, especially on any website or in any other online or offline networked computer environment without prior written authorisation from Grossmann.

## **Termination**

Grossmann may terminate its authorisation for authorised Journalists to use the Press Kit at any time. The violation of these Terms and Conditions of Use by authorised Journalists in any manner shall automatically and immediately void their authorisation to use the content of the Press Kit. Any unauthorised use of the Press Kit content by you outside your capacity as an authorised Journalist may violate notably intellectual property rights, trademark laws, the laws of privacy and publicity, and communications legislation and provisions. In the event of termination by Grossmann for any reason whatsoever, any and all copies of the Press Kit and/or any of its content made in any format on any support must immediately be destroyed and/or deleted. Furthermore, authorised Journalists will be held responsible for any damage incurred by Grossmann as a result of misuse of the Press Kit and/or any of the content contained therein by any unauthorised person.
